The Daily Point of Light award, created by President George H. W. Bush in 1989, honors individuals and volunteer groups around the country who are helping to meet critical needs in their communities and creating change every day.

In February of 1992 the Community Dental Clinic a program of Crawford-Sebastian Community Development Council, Inc., was recognized as the 699th Point of Light.

On Friday, October 16th, Nenya Perry, Community Dental Clinic Director, attended the Presidential Forum on Service commemorating the 20th Anniversary of the vision of a thousand "Points of Light" invoked by President George H. W. Bush in 1989. The 2009 Presidential Forum on Service celebrated the enormous advances of the service movement that started under his initiative and has been sustained through the leadership of Presidents William J. Clinton and George W. Bush. The service movement continues to gain momentum under President Barack Obama with the passage of the Edward M. Kennedy Serve America Act and the United We Serve initiative. The event also celebrated more than 4,500 Daily Point of Light Award winners.

### **Homelessness Prevention & Rapid Re-Housing Program**

The Homelessness Prevention and Rapid Re-Housing Program (HPRP) is made possible through a partnership

between the Department of Housing and Urban Development (HUD), Arkansas DHS, Crawford-Sebastian Community Development Council and the Old Fort Homeless Coalition. Funding of this program was made available through the American Recovery and Reinvestment Act (ARRA).

HPRP is focused on housing for homeless and at-risk households. It will provide temporary financial assistance and housing relocation and stabilization services to individuals and families who are homeless or would be homeless without this assistance. The funds under this program are intended to target two populations of persons facing housing instability: (1) individuals and families who are currently in



housing but are at risk of becoming homeless and need temporary rent or utility assistance to prevent them from becoming homeless or assistance to move to another unit (prevention) and (2) individuals and families who are experiencing homelessness and need temporary assistance in order to obtain housing and retain it (rapid rehousing).
