## World Changers

At the City of Fort Smith Board meeting held at 6:00 p.m. on Tuesday, August 17th a recognition ceremony took place.

324 youth from the Southern Baptist Alliance came to Fort Smith to work on houses of low-income residents in the area. Local businesses donated labor and materials to assist in the projects.

C-SCDC's Weatherization Assistance Program partnered with the City of Fort Smith and other sources to complete the windows, doors, insulation and other energy saving measures on one of the homes.

Ten thousand hours of labor was donated with in-kind being over \$100,000. City of Fort Smith Senior Planner, Brenda Andrews stated that this was the first time ever that there was this many volunteer hours and money donated at one time.

Winner of Survivor Samoa, Natalie White emceed the event and attendees were able to get their picture taken with her.

Award winners were Laura Houston, Affordable Housing Agent of the Year; Kralicek Realty, Affordable Housing Broker of the Year; Rausch Coleman Homes, Affordable Housing Builder of the Year; Federal Home Loan Bank of Dallas, Community Investment Award; UA of Fort Smith Foundation and the Innovations and Entrepreneurship Center, Innovative Partnership Award; USDA Rural Development, Affordable Housing Funder of the Year.

Alice Rufus, Little Rock Field Office Director, Department of Housing and Urban Development, presented the Recovery Award to the City of Fort Smith for being one of the first in the State of Arkansas to complete their ARRA projects.

The Weldon Ramey Resilience Award which is given to a person who has faced adversity and triumphed,

and who has persevered during hardships was awarded to Juan Carlos Gabriel. Born in Guatemala, J.C. had contracted polio at a young age and was left at an orphanage by his natural parents. He came to the United States for medical treatment and was adopted by Linda and Otto Gabriel. J.C. earned his degree in Early Childhood Development in 2005 and works as a substitute teacher for the Van Buren School District. He is a hard worker who has never let his disability keep him from being independent. With the assistance of the Self-Help Housing Program J. C. built his own home last year and was at the site daily scooting out of his wheelchair to help wherever possible.

### The Home In My Heart

Wonderful news! 2011 sees the implementation of a new C-SCDC Children's Creativity Competition. *The Home in my Heart* will be an annual children's creativity competition which will take place every February to coincide with Valentine's Day.

Each year the theme and nature of the competition will change, ranging from art and photography to essay and poetry. The competition will be subdivided into three age categories: 0-7 year olds, 8-13 year olds and 14-18 year olds.
